Dealer Agreement/Application

This agreement entered into by _____, here unto referred to as “Dealer,” and Collectibles Quality Assurance Company, LLC, a Minnesota based LLC with its primary business office at 401 Front Avenue, Suite 201, Coeur d’Alene, ID 83814, here unto referred to as “The Company” or “QA✓”, dated _____, shall be binding on both parties as to the covenants set forth below.

Terms and Conditions

- 1) Dealer agrees to submit acceptable coins on QA✓ submission forms, with a single tier service per submission.
- 2) Cracked/chipped or damaged holders will not be stickered. They will be returned with the other coins in a submission.
- 3) Payment by check must accompany your order. No credit card orders or “on account” orders will be accepted.
- 4) Return postage provided by QA✓ will be at the published current rate. If the USPS increases rates and such rates are not reflected on the then current submission form, Dealer will be charged the increased rate.
- 5) At the Dealer’s request, QA✓ will ship coins via the Dealer’s USPS or Federal Express account. Once a package has been accepted by Federal Express or the USPS all liability is transferred to the Dealer. It is assumed that the Dealer has adequate insurance coverage for the

contents of the package. In order to utilize this option, a Return Shipping Authorization Form must be on file.

- 6) Assigned verification by QA✓ is final and is the sole opinion of QA✓. There is no financial representation made by the verification. The numismatic marketplace will value all coins. QA✓ may maintain a price guide that provides an estimated value of coins it verifies. Such estimated valuations are not an open bid to buy or sell any coins.
- 7) QA✓ will not engage in the buying or selling of coins. Existing and subsequent entities wholly or partially owned by QA✓ or it's owners/employees may engage in the buying and selling of coins QA✓ has verified and non verified coins, both raw and slabbed.
- 8) QA✓ Dealer and its employees agree that it will not disparage The Company, it's products or it's employees. The company agrees that it's employees will not disparage the Dealer or it's employees.
- 9) QA✓ may alter the terms of this Agreement at any time. Dealer will be notified of any such changes via electronic means or regular US Mail. By submitting coins after receipt of such notification, Dealer has agreed to those new terms. If the Dealer does not agree to any revised terms, the Dealer must submit a letter to The Company within 30 days of the published date of change. If the Dealer does not accept the revised terms, this Agreement between The Company and the Dealer will automatically terminate.
- 10) Dealer pricing for Silver Tier is \$10.00/coin and for Platinum Tier is \$20.00/coin. This is a \$2.50 and \$5.00 discount to published prices. Re-stickering coins with original cert number is \$3.00
- 11) QA✓ is not affiliated with PCGS, NGC or any other grading service.
- 12) In order to maintain Dealer status, a minimum of 25 coins must be submitted annually.
- 13) All disputes shall be enforced under the laws of the State of Minnesota.
